RESOLUTION NO. 04-23

AUTHORIZING THE CHIEF EXECUTIVE OFFICER TO APPROVE  
THE TITLE VI EQUITY ANALYSIS AND FARE STRUCTURE OF THE TOLEDO AREA REGIONAL  
TRANSIT AUTHORITY EFFECTIVE THURSDAY, JANUARY 19, 2023

WHEREAS, TARTA opted to rollout a pilot fare structure that prioritizes equity and affordability for our customers, while not negatively impacting agency budget, riders, and/or any minority census tracts; and

WHEREAS, TARTA introduced the pilot fare structure August 1, 2022, and conducted a rider survey to analyze the impacts of the new fare to minority census tracts and any members of our disadvantaged communities as required by the Title VI regulations; and

WHEREAS, in accordance with federal regulations, TARTA conducted public meetings consistent with the federal Title VI requirements and produced a report of all Title VI activities; and,

WHEREAS, the fare structure as set in place on August 1, 2022, has no significant negative impacts on the minority census tracts or members of any disadvantaged communities within our service area; and,

WHEREAS, TARTA wishes to continue the new fare structure as instituted on August 1, 2022, to continue in effect until further notice; and,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOLEDO AREA REGIONAL TRANSIT AUTHORITY, OHIO

SECTION 1. That the new fares as instituted by TARTA on August 1, 2022, remain in effect until adjusted and/or changed by this Board of Trustees.
