COMMENDING KELSIE HOAGLAND FOR OUTSTANDING SERVICE AND LEADERSHIP  
TO THE TOLEDO AREA REGIONAL TRANSIT AUTHORITY AND  
TO THE RESIDENTS OF LUCAS COUNTY AND THE CITY OF ROSSFORD

WHEREAS, Kelsie Hoagland has represented the City of Waterville on the Board of Trustees of the Toledo Area Regional Transit Authority since August 1, 2019; and

WHEREAS Ms. Hoagland has completed two terms as President of the Board of Trustees from 2021 to 2022; and

WHEREAS Ms. Hoagland has provided exceptional leadership and dedication to both the Board of Trustees, TARTA employees and the customers who depend on TARTA every day; and

WHEREAS Ms. Hoagland has provided this leadership during one of the most notable periods in TARTA's history, which was the passage of Issue 12 that brought financial sustainability to the Authority by changing the local funding source from property taxes to a sales tax and expanded TARTA's service area to all of Lucas County; and

WHEREAS, Ms. Hoagland oversaw the reconstitution of the TARTA Board of Trustees to include new representation of Lucas County; and

WHEREAS, Ms. Hoagland served as Board President during TARTA's development and Board adoption of a comprehensive operational analysis called TARTA Next which has led to major service expansion in new areas of Lucas County, launch of a microtransit service, customer experience enhancements and creation of TARTA Zero campaign which has a goal to make the Authority's fleet entirely zero emissions by 2040; and; and

WHEREAS Ms. Hoagland has completed her service on TARTA's Board of Trustees.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOLEDO AREA REGIONAL TRANSIT AUTHORITY, OHIO:

SECTION 1. That TARTA's Board of Trustees, management and employees recognize Kelsie Hoagland for her considerable service to the Board of Trustees from 2019 to 2024.

SECTION 2. That the Board of Trustees, management and employees hereby express sincere thanks, appreciation and commendation for outstanding leadership and exceptional commitment of time, talents and effort in representing TARTA, the entire transit community and the City of Waterville.
